Dismissal and Termination

Southwest Florida Dog Grooming Academy and Instructor Isabel Campos reserves the right to terminate enrollment of student for the following:

- Being absent without contacting the instructor for two (2) full days.
- Excessive absences.
- Habitual tardiness.
- Poor attitude.
- Roughness with the animals.
- Disrespect towards fellow students or staff.
- Effort of student not up to potential, or if Instructor discovers problems with performance due to; medical condition, medications, illegal drug use, or alcohol abuse that may impair Student from working safely with the animals.

Any such expulsion will be without refund.

Refunds

1. All money paid by the student shall be refunded if requested within three (3) days after the execution of this agreement/contract.

2. The student may cancel this agreement/contract after more than three (3) days from the date hereof and at any time prior to the scheduled date of commencement of classes, in which Student will be entitled to be refunded all money paid with the exception of half of the tuition deposit (\$500.00).
3. If the student wishes to withdraw from classes within the first two weeks of the training program, the student will be entitled to a refund at a prorated portion of the tuition (\$100.00 per attended day).
4. No refunds will be issued after the second week of the training program. The student will be entitled to equipment pertaining to the program.

Student agrees to the following:

1. Student has read and understands this agreement/contract before signing.
2. Student has full knowledge that the services provided by the instructor are of training and education and no employment is offered or guaranteed to the Student.
3. Southwest Florida Dog Grooming Academy will not assume any liability for any injury/injuries the student may obtain while training.
4. The Student understands that he/she/they will be responsible for any injury that may occur to an animal during the training course, including veterinary care, follow ups to a veterinarian and/or any medications.
5. The Student has received a copy of the training and instruction rules for the training program and the facility, and agrees to follow them accordingly. Consistent violations of these rules are grounds for termination.

DO not sign this agreement / contract before you read it. You should retain a copy of this agreement / contract for your records. This agreement / contract becomes legally binding at the time it is accepted by Instructor Isabel Campos and Southwest Florida Dog Grooming Academy.
